

## **Cannae Holdings, Inc. Privacy Notice**

**Effective December 9, 2021**

Cannae Holdings, Inc. ("Cannae") recognizes the importance of protecting your personal and financial information when you visit [www.Cannaeholdings.com](http://www.Cannaeholdings.com) and [Investor.cannaeholdings.com](http://Investor.cannaeholdings.com) (separately and collectively, the "Website"). This Notice explains the Website's information collection and use practices. By visiting the Website, you agree to and accept the practices described in this Privacy Notice.

Cannae's business consists of managing and operating certain majority-owned subsidiaries, as well as making equity investments in businesses. This Privacy Notice does not apply to Cannae's subsidiaries which have their own privacy policies, or to businesses in which Cannae has investments.

**Information Collection** We may collect two types of information when you visit the Website - Personal Information and Automatic Information. Automatic Information includes Usage Information and Cookies.

**Personal Information:** Generally, you can visit and browse the Website without providing any Personal Information. The Website's "Contact Us" feature allows you to send us information, including personal information such as name, e-mail address, and other information you may choose to provide to us. Whether you submit Personal Information is entirely up to you, though your election not to share this information may limit our ability to service you or provide certain services.

**Usage Information:** The Website receives and may record certain types of information regarding users' interaction with the Website. This includes Website traffic and usage information, including, for example, IP address, Operating System, Internet browser, and Service Provider used, and the numbers and frequency of visitors to the Website. Use of this data is in the aggregate to help us diagnose problems, analyze trends, and improve our Website. Currently, our policy is that we do not recognize "do not track" requests from Internet browsers and similar devices.

**Cookies and similar technologies:** Cookies are small text files that are transferred through your web browser to your computer. Cookies are used to recognize, measure and track visitors to a website. Cookies help us improve the way our Website works, for example, by determining whether site visitors can find information easily, or by identifying the aspects of the site that are of the most interest to users. Cookies cannot access, read, or modify any other data on a computer. You have the ability to accept or decline cookies. Check the "Help" menu of your Internet browser to learn how to change your cookie preferences. If you choose to decline cookies, you may be unable to make full use of the Website or benefit from personalized features on the Website.

**Information Use and Sharing** We do not rent or sell your personal information to anyone. We share your personal information only with entities that are controlled by or under common control of Cannae and as described below:

- We use your information for our everyday business purposes, for our own marketing purposes, and to provide services you have requested.
- We employ service providers to perform services on our behalf and may need to share your information with them to provide support to our organization or to assist in providing services to you. The service provider uses your information only to perform their duties and is not permitted to use your information for any other purpose.

- We may disclose your information (a) to the government or private parties in connection with a lawsuit, subpoena, investigation, similar proceedings or regulatory examination, (b) to comply with applicable laws or regulations, (c) to enforce this Privacy Notice, or (d) when we believe in good faith that disclosure is necessary to protect the rights, property or safety of Cannae, our employees, our users and others.

By sharing your information with Cannae, you authorize us to disclose any such information in those circumstances.

**Business Transfers:** We reserve the right to transfer all or some of your information in connection with the sale or other disposition of all or part of the Cannae business and/or assets, or in the event of a bankruptcy, reorganization, insolvency, receivership or an assignment for the benefit of creditors. You expressly agree and consent to the use and/or transfer of your information in connection with any of the above described proceedings.

**Information from Children** The Website is not targeted toward or designed to attract children. We will never knowingly request personally identifiable information from anyone under the age of 13 without prior verifiable parental consent.

**International Users** If you reside outside the United States or are a citizen of the European Union, please note that we may transfer your information outside of your country of residence or the European Union for any of the purposes described in this Privacy Notice. By providing Cannae with your information, you consent to our collection, use, and transfer of such information in accordance with this Privacy Notice.

**Third Party Websites** Cannae may establish links between this Website and one or more websites operated by third parties, including websites of our affiliates or business partners. Cannae has no control over any such other websites, and this Privacy Notice does not cover the information practices of those third parties. Your access to and use of such linked websites is governed by the terms of use and privacy policies of those sites, and shall be at your own risk. Cannae disclaims responsibility for the privacy policies and customer information practices of third-party websites linked from our Website.

**Privacy Notice Changes** Cannae may change this Privacy Notice from time to time. Changes shall be effective immediately upon posting.
